Financial Value Transparency/Gainful Employment (FVT/GE) Overview

The Financial Value Transparency/Gainful Employment (FVT/GE) Act creates a financial value accountability and transparency framework that provides the public with information about the cost of postsecondary programs and the expected outcomes upon completion.

There are two components of this framework:

- **Gainful Employment (GE):** Accountability framework that allows the Department of Education to evaluate the extent to which programs prepare students for gainful employment. It includes a metric about debt-to-earnings and another metric about earnings graduates make relative to typical high school graduates. Eligible programs that do not meet one or both metrics may be subject to warnings and/or removal of Title IV/HEA federal student aid program eligibility.
- **Financial Value Transparency (FVT):** This reporting is similar to the GE reporting but without the accountability framework. Under this component, data will be provided to the public on typical earnings outcomes, borrowing amounts, cost of attendance, and sources of financial aid.

The Department of Education has provided colleges with some of their data. As part of reporting, colleges are expected to validate data as well as provide additional data.

SBCTC has created queries to assist colleges with gathering the required data. This data dictionary details and supports the financial aid data required for FVT/GE reporting.

Data dictionary structure

Each query is separated into Total Amounts (TA) and Annual Amounts (AA) reporting requirements.

Each field includes:

- The FVT/GE reporting element (as appropriate)
- An indicator if the field is mandatory for FVT/GE reporting (i.e., if it's a required element for FVT/GE reporting)
- A definition of the field
- The dataLink source for the element
- Any guidance from the Department of Education on how to report the element
- Any additional notes about how the field was pulled (as appropriate)

Financial aid queries overview

The PSQueries available to support student reporting are:

- QCS_FA_GE_FVT_GRANTS (Financial Aid Disbursement Data)
- QCS_FA_GE_FVT_COA (Cost of Attendance Data)
- QCS_FA_GE_FVT_DEBT (Institutional Debt, and Tuition and Fees)

These three queries are designed to be merged with the FVT/GE student lists obtained from NSC or directly from DOE/NSLDS.

Which students are included in the queries?

A student may have multiple rows in the dataset if they were enrolled in different academic plan codes. Colleges may need to roll up academic plan codes in their reporting of the student, depending on reporting requirements (e.g., a program may have a mix of academic plan codes that do and do not meet GE reporting requirements).

These queries include all students who had an active financial aid term during the aid year(s) selected. Only students with Title IV aid from the college need to be reported for FVT/GE. See “Running the queries” below for information on how to limit query results to only students who received Title IV aid from the college.

How to use the financial aid queries

Query roles required

These queries contain SSNs and therefore require someone with the appropriate roles to pull the data. The following roles are required:

- ZD_DS_QUERY_VIEWER
- ZD_DS_QRY_FINANCIAL_AID
- ZD_DS_QRY_STUDENT_RECORDS
- ZD_DS_QRY_STUDENT_FINANCE
- One of the following:
 - ZD_DS_QRY_FA_SSN_HIGHSEN,
 - ZD_DS_QRY_HR_SSN_HIGHSENS, or
 - ZD_DS_QRY_SR_SSN_HIGHSENS

Running the queries

The three queries can be run for Annual Amounts (AA) and Total Amounts (TA). Queries have prompts to adjust the results:

- Institution
- Award Year
- A checkbox prompt for “Show only for Award Year.” This checkbox should be checked for AA fields and left unchecked for TA fields.

- Title IV Aid. This checkbox should be checked to limit results to only students who received Title IV aid and left unchecked to include students who received any kind of financial aid.

Note that since the same query can be used for AA and TA students, the results include all fields you need to report across both categories. Only the years reflected in the data change between the Award Year prompt.

Merging the queries with NSLDS/NSC student data

Once the query data are pulled, they need to be merged with the college's student lists. Many colleges have opted to receive their lists through the National Student Clearinghouse (NSC), but colleges can also receive their student lists directly from the National Student Loan Data System (NSLDS).

Note that the student lists from NSC/NSLDS include students who received Title IV aid for a program from *any* college. Colleges need to identify which students in their lists received Title IV from their institution, and report only on those students.

Use the [NSLDS student submittal user guide](#) and/or [NSC Student-Level Reporting Specifications](#) to determine which fields need to be reported for which kind of student.

R and Python scripts

If you are familiar with R and Python, there are scripts available to assist you with merging financial aid data with student list data in the NSC format. They can be found on [the SBCTC Data Dictionaries website](#) in under the Financial Value Transparency/Gainful Employment header.

Students who started in Legacy

If students began their program prior to a college's go-live quarter, financial aid data will need to be pulled from Legacy. The SBCTC Policy Research team is currently working on a script to assist with this.
