



District Assurance for Bridge to College Implementation

This school district assures the Office of Superintendent of Public Instruction (OSPI) of its commitment to:

1. Identify Participating Schools

- Designate high school(s) that will offer Bridge to College courses in Math and/or English.
- Support school leadership (principals or administrative designees) in implementing these courses.

2. Registration Fees

- Pay per-teacher registration fees: **\$1,750 per new teacher** and **\$750 per returning teacher**.
- If a teacher attends the Institute but does not teach a Bridge to College course, the district will still be charged a reduced fee, as determined by the State Board for Community and Technical Colleges (SBCTC), to cover incurred expenses. The specific fee amount will be communicated separately.

3. Teacher Participation

- Ensure **new teachers** attend the required **Summer Institute on August 4-6, 2026**.
- Support all Bridge to College teachers in participating in professional development during the regular school year, including curriculum workshops and Community of Practice meetings.
 - New Bridge to College teachers are required to participate in at least 15 hours of professional learning, in addition to the Summer Institute. Additional asynchronous learning opportunities (up to 5 hours) may be available but are optional.
 - Returning Bridge to College teachers are required to participate in at least one professional development activity.

4. Additional Financial Support for Teachers

- Provide funding for travel, time, substitute coverage, or supply costs for the Teacher Institute and school-year professional learning. Note, each teacher registration fee covers the Teacher Institute event participation, some meals, and accommodations.
- Districts are responsible for ensuring substitute coverage for teachers' professional learning activities.

5. Course Naming and Coding

- Use the specified Bridge to College course name and code in CEDARS and school catalogs:
 - **Math:** Bridge to College Mathematics – WA 0003
 - **ELA:** Bridge to College English Language Arts – WA 0001
 - **ELA:** Bridge to College English Prep- WA 0049
- **Instructional delivery:**
 - Bridge to College English can be taught in person or online
 - Bridge to College Math **must be taught at least 50% face-to-face** and is not designed or suited for a fully online environment.

6. Communication and Collaboration

- Respond to communications and requests from OSPI and SBCTC in a timely manner, including updating registration with current teacher information.
- Collaborate with OSPI, the State Board for Community and Technical Colleges (SBCTC), and program evaluators to support course evaluation and refinement.
- Provide requested student data and allow classroom observations for the purposes of program evaluation, continuous improvement, and alignment with postsecondary expectations

- Implement Bridge to College courses using the state-approved curriculum and assessment materials provided through the program.
