- Noah Overby provided overview of challenges folks face when trying to access dashboards and provided solutions, presented useful dashboards, provided hands-on practice, and answered questions
- Questions/concerns that came up:
 - Highline shared concerns about collapsing transfer data for multiple campuses of same institution
 - Bellevue: Does the transfer dashboard capture transfer even for students who don't earn associate or certificate?—answer is yes
 - Cascadia: Can we follow a student from basic skills to bachelor attainment? —no dashboard currently exists
 - Pierce: Are we having conversations about student group data mining at SBCTC?—no
 - Shoreline: Do dashboards include reverse transfer?—yes, but you cannot disaggregate by reverse transfer

Transitions and Transfer

- Planning to do some surveys—survey will go out after winter meeting
- Asking ATC to ask your IR leads for permission to share data regarding co-reqs before Winter meeting
- Looking at potential of centralizing transfer through Universal Credit Transfer Explorer
- Data to send out by May

Degree Maintenance

- Responding to ICRC memo that 1) asked how DTA is working for students after pathways work 2) challenged the equity effect of local requirements of DTA 3) requested commonality in diversity requirement throughout system
- Discussed ceiling of DTA requirements and whether or not additional requirements are equitable; establish the range of appropriate deviation from DTA
- Discussed making recommendations to make DTA more flexible to make room for major-ready courses
- This change would benefit running start students as well because it would make it easier for them to meet high school graduation requirements as well as DTA requirements
- Workgroup shared conceptual draft: Communications 10 credits, Quantitative/Symbolic Reasoning Skills (5 credits), Humanities (10 credits), Social Sciences (10 Credits), Natural Sciences (10 Credits), Pathway Specific/Major Ready Distribution Courses (15 credits)
