ATC Update from ICRC

ICRC Spring 2025 Meeting (April 10-11, 2025)

The Intercollege Relations Commission (ICRC) held its Spring 2025 meeting in Spokane at SFCC on April 10-11, 2025, with representatives from approximately twenty-five Washington higher education institutions and multiple agencies in attendance. Key highlights included:

Financial Changes

• New dues structure approved for 2025-2026: \$150 annually for institutional members (two attendees each), \$50 annually for agency members

Leadership Updates

- Appreciation shared for Dave Sundine's time on the executive board
- Axi Bontrager (City University) elected as the ICRC Member at Large
- Melissa Sitzenstock concluding role as OAR Committee chair, with Amber Brock (Tacoma CC) assuming committee leadership. Austin Colburn (South Seattle) joined the OAR Committee.

Committee Activities

- Ongoing Articulation Review Committee working through institutional review schedules
- Handbook Review Committee working on constitution modernization

Major Discussion Topics

- 1. Direct Transfer Agreement (DTA) Reform Discussion:
 - Process and Timeline if DTA revision is supported at ATC's May 2 meeting
 - Concerns about faculty representation in decision-making process
 - o Mixed feedback on impacts to institutional identity and student transfer pathways
 - Request for data on transfer without a degree, excess credits
 - ATC feedback to investigate performance courses in the Humanities distribution and alternative courses that might fulfill QSR requirements. Consider impacts to Running Start, 'Frankenstein degrees', transfer ready vs. major ready, and limited electives at the BI's under current DTA structure.

2. Transfer Course Policies (Q&A)

- Discussion on acceptance of online lab sciences
- Clarification on ENGL& 235 and other English composition transfers
- Questions about "shelf-life" for specific courses (Math, Computer Science)
- Credit for Prior Learning transcript clarity

Upcoming Meeting - Fall 2025: October 9-10 at Whitman. Summer survey expected to identify barriers to inperson attendance.

DTA Revision Process Timeline

Key Actors

- ATC (Articulation and Transfer Council): Deans and academic leaders responsible for initial recommendations
- IC (Instructional Commission): VPs of Instruction who evaluate, act on, and advance proposals
- JTC (Joint Transfer Council): Final draft for signatures from all 3 sector approval bodies

Process Timeline

May 1-2, 2025: ATC Spring Meeting

- ATC will take a formal vote on whether to advance proposed DTA revision changes (see below)
- Will and Kerry (State Board and IC representatives) will be available during the meeting if needed
- Results communicated to Kerry and Will immediately following vote

May 12, 2025: JTC Meeting (via Zoom)

- Informational update on process withing SBCTC
- No voting action at this stage
- Baccalaureate Institutions (BIs) partners already familiar with proposed changes

May 15, 2025: IC Transfer Committee Meeting

- Reviews ATC's recommendations
- Evaluates proposal content
- Determines whether to advance to full IC business meeting

May 16, 2025: Full IC Business Meeting

- Discusses and potentially votes on ATC recommendations
- If approved, prepares for JTC formal review

July 14, 2025: JTC Summer Meeting

- Earliest possible formal review of IC approved proposal
- Seek feedback from BI sectors (public universities, ICW)

Fall 2025 - Summer 2026: Implementation Planning

- JTC review feedback from BIs
- Transfer Committee of IC review JTC feedback for any changes

Winter 2026:

- New DTA requirements could take effect
- Current students would be able to continue under existing requirements
- JTC vote on final recommendation
- Collect signatures from sector leads
- Send to ICRC for final implementation

Important Process Notes

- Local VP conversations with faculty, advisors, and registrars should happen **before** the May IC meeting
- VPs are responsible for gathering campus input to inform their IC vote
- ATC representatives serve as points of information in local discussions
- Goal is sector-wide consensus
- Final approval requires signatures from participating sectors
- Earliest catalog year would be 26-27, with a 2-year teach-out under the current requirements.

Motions for ATC Vote

ATC will take a formal vote on the following four points regarding DTA revision:

- 1. **MOTION POINT ONE**: The DTA (Direct Transfer Agreement) requires revision to more equitably serve student transfer needs.
- 2. MOTION POINT TWO: The revised DTA should include a diversity course requirement.
- 3. **MOTION POINT THREE**: The revised DTA should reduce distribution courses from three to two in each of the three distribution areas core areas: Humanities, Social Science, Natural Science
- 4. **MOTION POINT FOUR**: The revised DTA should limit local variations from DTA credit restrictions to a maximum of:
 - Option A: Five (5) credits, OR
 - Option B: Ten (10) credits, OR
 - Option C: No specific credit limit

The results of this vote will be forwarded to the Instructional Commission Transfer Committee for consideration at their May 15th meeting.

Leading the Human Side of Change, Carlee Osburn, EAP

- <u>See slides</u>
- Change can impact employees and can lead to decline in productivity, enthusiasm, and morale
- Group discussed impacts of poorly managed change
- Change vs. transition—change is external (decision someone else made), transition is internal—the gradual, psychological orientation process as we adapt to change
- Transition is what we want to focus on because it is what we can impact
- Group discussed how leaders can support their teams during change
- Change can impact mind, emotions, behavior, and body in negative ways
- Change comes in waves (leaders of change, folks in the middle, and people at the end catching up), people at the front can experience fatigue from bringing everyone along
- Resource: William Bridge's Transitional Model
 - o Beginning of change (Ending, Losing, and Letting Go) feels like end and causes grief
 - o Neutral Zone is time of ambiguity (this is where people need most support to persist)
 - o The New Beginning is when changes have been accepted and energy is high
- Group discussed challenge of being in the middle during change in our roles
- Key Change Strategies: Clear Communication, Empathy in Action, Stakeholder Involvement, Be Present, Recognize and Celebrate Wins, Foster Resilience, and Offer Support
- Know your leadership self—What is your style? What is your response to change? Engage in self-awareness
- Leader presence is critical in navigating change
- Building Momentum Through Leadership: Lead with Empathy, Foster Psychological Safety, and Celebrate Small Wins
- Communication: Be Transparent, Tailor Your Message, and Practice Active Listening
 - o Cultivate Trust, Create Change Champions, Encourage Collaboration
 - Support Individuals Through Transition—Recognize Individual Needs, Address Resistance, Offer Tailored Resources
- Actionable Tools to Drive Change: Leadership Playbook, Feedback Loops, Self-Assessments

ATC Discussion Items

10:45 – 11:45 CWU Equity Requirements Change and DTA Draft Proposal

- CWU Equity Requirements Change
 - o Discussed possibility of streamlining process for articulating diversity/equity courses
 - Val shared work towards shared definition of the outcomes of community college diversity/equity courses. This is on-going work/discussion.
 - o Concerns were expressed about federal funding being halted due to DEI-related courses.
 - o Shared difficulty in aligning outcomes with so many different 4 years
 - o ICRC Chair Audrey Minton discussed options for making articulation of diversity/equity requirements more streamlined. Discussions will continue in ICRC.
- Revised DTA draft proposal
 - o As a reminder, there are two issues at hand
 - Desire to create more flexibility in DTA for students to better prepare for desired pathway
 - Desire to limit additional local DTA requirements at individual community colleges
 - o Amy from Bellevue share proposed changes to DTA which includes more flexibility in distribution requirements
 - Pierce's feedback from registrar was to make it clear that those floating 15 credits are GTE and not GE (using the current DTA distinctions of electives)
 - Deans shared that faculty have concerns about impact of enrollment in specific courses—discussed the tension between this concern and the burden put on students when they are not able to take courses they need for their pathway
 - o Draft language needs to make it clear that the additional elective designation requirements are limited to 5 credits WITHIN the 90 (not additionally)
 - o Discussed whether we want to limit "credit-less requirements" like interdisciplinary requirements
 - o Discussed whether or not the 5-credit limit for additional requirements was too much
 - o Intent is to apply pressure on institutions to look at barriers of additional local requirements
 - o Folks asked how this would impact MRPs
 - o Amy from Bellevue asked Val how baccalaureates might respond
 - This shift would align with what four years are asking for

- Would it be possible to have a summit where representatives from all colleges bring their examples and rubrics and have a facilitated conversation about common outcomes to see if there's something that we could agree to? - Would be a good opportunity for open dialogue and what is best for students.
- Are the previous transfer summits examples of what this could look like?
- ICRC and Washington Council each have their own funding, could they sponsor facilitation?
- Does every 4 year have a diversity requirement? Not all, a few don't.
- Propose that we endorse the Diversity requirement in the DTA. Also important for universities to then take that back to their institutions and see if it would meet their own DEI requirements.
- Is there room for this conversation at an upcoming ICRC meeting? Could begin this Spring on day 2 of the meeting in April.
- Audrey will send it as pre-work to Spring ICRC to bring their diversity outcomes/requirements to the meeting.
