

Update on the status of differentiating between admin except and prof/tech exempt. - Carmen

- Carmen talked to project staff. Job screen in PS, part of configuration. You have to put an EEO Job category for each employee. EEO 6 is exempt. Then you apply an EEO Job Group to narrow down.
- No coding manual exists for HCM at the state level. We need to have something for IR. Metalink will have some of the data. But is that enough? Marshall says not all schools are as willing to standardize, because they may be more unique. Not all colleges do an affirmative action report (runs counter to state law), and may feel like this is an extra step. However, this is at the job level so it not a large time impact to whatever staff is responsible for this. Even though steps may increase for one person there may be a positive impact further downstream. Users need to understand how the information they input is used.

- Discuss implementation Carmen would add some detail in the datawarehouse so we
  can report at a more detailed level. Do we need to vote, do we need to take to
  commissions? Terence says put it in place and communicate it. Communicate the
  benefit to people why have we done this. Allows us to track and report EEO for
  exempt. State can run the reports automatically and not have to go to the colleges.
- Terence suggests we need a rubric for what we need to review and what goes to commissions. Carmen mentioned the workbook that was developed. All agree to use the notebook. Carmen will add a tab for working with the governance process.
- What is the relationship between changes that we as DGC recommend and get the project staff to agree to change? Are we circumventing the ctcLink governance process?
- Jan 2019 PS upgrade is another upgrade timeframe option.

- Learning Communities WA center definition of learning communities, "A cohort of students taking 2 or more courses together." <a href="http://wacenter.evergreen.edu/what-is-an-lc">http://wacenter.evergreen.edu/what-is-an-lc</a>. LC will be a global attribute. We do want IC feedback on the definition to make sure there are no issues. Could send out via email along with the definition being developed for low cost.
