# February 13, 2025

## **Call to Order:**

The meeting was called to order at 8 a.m. by Pete Lortz.

## **Legislative Activities:**

The commission traveled to the Washington State Capitol to meet with legislators and discuss their agendas, planned work for the 2025 session, and commission priorities for future legislative sessions.

# **Committee Breakout Reports:**

#### Dual Credit:

Bryce Humpherys (Big Bend Community College) shared a draft document with ideas for identifying and determining faculty credentials.

#### College Transitions:

Will Durden (State Board for Community and Technical Colleges) reported that a \$25.00 tuition charge will remain due to government budget shortfalls, and the "Ability to Benefit" program will be on hold until later in the year.

## Transfer:

Updates on transfer included the Baccalaureate Learning Council (BLC) working on revising policy and updating by-laws, while the Articulation and Transfer Council (ATC) discussed revisions to the Common Course Numbering (CCN) within the Direct Transfer Agreement (DTA) in response to a request from the Joint Transfer Committee (JTC).

#### Workforce:

Heidi Ypma (Bellingham Technical College) provided updates on the Workforce Education Council (WEC) workplan, focusing on the full implementation of the 2024 Skill Standards for Professional/Technical Instructors by June 2025, strengthening Workforce partnerships and data systems, and developing resources for new Workforce leaders. Highlights from the

Winter WEC meeting included sessions on student success, equity gaps, and updates from Employment Security staff. Upcoming Centers of Excellence (COE) events include Cybersecurity and Homeland Security Emergency Management.

## Learning Strategies and Innovation:

Stephanie Delaney from Renton Technical College presented on organizing AI and supporting future use, ensuring accessibility compliance, and provided updates from the Library Leadership Council (LLC).

# Washington State Board for Community and Technical Colleges Report:

Joyce Hammer shared upcoming events for the Washington State Board for Community and Technical Colleges, including an Al Summit and the Assessment Teacher and Learning (ATL) conference in Vancouver. Federal updates were presented by Will Durden and Joyce Hammer, covering BEDA and Department of Education matters. Jamie Traugott provided an update on the WSSSC meeting regarding Title IX and the Washington Student Experience. Enrollments are up by 8% across the system.

## Capital Budget:

Heidi Ypma reported on the Capital Budget, noting that the BAC report was pushed to the February meeting. She also mentioned that a Condition Survey contractor would be visiting colleges, and the next meeting was scheduled for February 27th.

#### Educational Services:

Kristen Finnel reported on Educational Services, noting that the workplan for January 13th was approved. She mentioned that the Guided Pathways advisory committee would provide a report at the next Educational Service meeting on February 27, 2025.

Peter Lortz reported on the Allocation Review Taskforce Report and AMRC survey.

## Technology:

Michael Lee provided updates on CTClink improvement plan, funding models, cybersecurity topics, and ADA compliance.

Cathy Leaker and Michael Lee discussed vendor demonstrations for SS software, with a timeline for contract approval in March.
