Promising Practices Exchange

The <u>Promising Practices Exchange</u> was created as a follow-up to the work of the Strategic Enrollment Task Force to capture and share emerging, promising and excellent practices in the following areas:

- K-12 alignment
- adult re-engagement
- onboarding new students
- retaining students
- responding to the COVID-19 pandemic

A webinar series is being planned on each of the themes during winter term.

Counselor/Student Ratio Task Force

All colleges responded to the survey assessing several areas related to the task force's work. Results of the survey will be used to develop the final report due to the Legislature at the end of November.

Washington was awarded a \$15 million CARES Act Recovery Assistance grant to develop a technical assistance program and prepare a comprehensive plan to aid the reopening of the state's economy. The committee meet with Chris Green, Department of Commerce assistant director, Office of Economic Development and Competitiveness, to discuss ways colleges can help support economic recovery.

Governor's Emergency Education Relief (GEER) funds

Economic recovery planning efforts

Reskilling and Recovery Network: The governor's office asked the State Board to lead an
interagency team participating in a multi-state network created by the National Governor's
Association and the American Association of Community Colleges. It is a short-term project
offering best practices dissemination and technical assistance on worker retraining strategies.

Washington Recovery Group: The governor's office is launching a coordinating group of state
agency directors, local government, tribal agencies and private sector representatives to
implement recovery strategies identified by the governor.
