Shared business office functions

The committee put forward a proposal from Eric Murray to explore potential options for shared business office functions. WACTC authorized Choi Halladay to study the potential of the State Board to offer centralized financial services for colleges that wish to participate.

2023-25 operating budget request

The 2023-25 operating budget request was submitted to the Office of Financial Management and includes:

- Provide Fully Funded, Competitive Compensation (\$157 million)
- Advance Equity, Diversity and Inclusion (\$26 million)
- Support Workforce Development Programs (\$77 million)
- Expand Learning Technology (\$93 million)

Legislative advocacy checklist

Deferred Action for Childhood Arrivals (DACA) program

The committee will work on a system statement regarding the Oct. 5, 2022 decision by the Fifth Circuit Court of Appeals. The court upheld a lower court's ruling that the Deferred Action for Childhood Arrivals (DACA) program is unlawful. The court also ruled current DACA enrollees could renew their status and sent the case back to a lower court to consider a regulation enacted by the Biden administration to strengthen the DACA program against legal challenges.
