



# CTCLINK GOVERNANCE PROPOSAL TO WACTC

## Executive Summary for WACTC — Approved April 28, 2022

ctcLink has already brought lasting change to the way our colleges do business and structure themselves across departments, as well as across the entire college system. As we approach the cusp of 34 colleges live in ctcLink, the Strategic Technology Advisory Committee (STAC) subcommittee was tasked with developing a governance model for ctcLink sustainability and collaboration. This model requires WACTC approval of guiding principles, governing charters, and formation of a new systemwide ctcLink Collaboration group.

### **Request for Approval**

- Revised ctcLink Guiding Principles
- Each college will designate a primary ctcLink leader to (a.) serve as the primary liaison with SBCTC for all ctcLink matters and (b.) to participate in the ctcLink College Collaboration Group
- ctcLink Program Governance

### **Governance Goals**

The proposed new governance model is designed to close gaps in the implementation phase governance process to meet the following goals:

- Engage in decision-making and business process alignment across our system with the designated ctcLink leader at each college
- Broad stakeholder participation in decision-making
- Ensure college subject matter expert input to prioritize changes and maximize limited system resources
- Establish transparent communication channels for clear processes and activity status

ctcLink Guiding Principles	Sets forth 10 overarching principles to guide ctcLink decision-making and investments, as well as ensure our work aligns with the mission, vision, values and goals of WACTC and SBCTC to prioritize equitable access to technology resources for students across the college system.
Strategic Technology Advisory Committee (STAC) Charter	The STAC Charter was revised to incorporate the new College Collaboration Group as a subcommittee and to establish its leadership role for ctcLink shared governance. STAC serves as an advisory resource and coordinating body regarding system-wide technology planning, selection and investment decisions.
ctcLink Working Group Charter	The Working Group Charter was revised to reflect a post-implementation governance model to provide guidance and support for ctcLink Operations throughout the life of the product, enable ctcLink system support and enhancement decisions, and maximize the overall business value of the ctcLink environment while ensuring the reliability and maintainability of system functions.
ctcLink College Collaboration Group & ctcLink College Leader	Each college is required to name a college ctcLink leader to serve as the primary contact and participate in the ctcLink College Collaboration Group. Titles may vary by campus (e.g. ctcLink Lead, ctcLink Coordinator).
ctcLink Governance Transition Plan	The current ctcLink Working Group will continue in its role until the new governance body is in place. This plan will be developed after approval of the governance structure.
